In consideration of mutual covenants and agreements herein contained, the parties agree as follows:

BETS grants VENDOR the right to occupy a space for the 2018 Badlands Circuit Finals Expo & Tradeshow, Thursday, October 4 through Sunday, October 7, 2018. VENDOR is required to be open for business during Expo hours.

Set up - Thurs or Friday **Thursday Oct. 3, 8 a.m. – 4 p.m.**
Friday Oct. 4, 8 a.m. – 4 p.m.

Business After Hours (Optional): Thursday, Oct. 3, 5 – 7 PM
Vendors wishing to set up for Business After Hours must be open by 4 p.m. Thursday, Oct. 4th.

EXPO HOURS: Friday 4 pm -10 p.m., Sat., 9 a.m. - 10 p.m., Sunday 12 p.m. – 4 p.m.

VENDOR shall pay BETS for use of said space. Vendor deadline is Sept 13, 2019 for contracts and space fee. 15% discount if payment received prior to August 31, 2019.

VENDOR is responsible for all necessary permits, licenses and insurance. To include but not limited to; Health Dept. permits, Off site sales, Sales Tax number, and in event employed staff is used, an Employer ID Number, workers compensation insurance, and such others as required by Law. VENDOR is responsible for all sales tax reports.

VENDOR acknowledges that it is an independent contractor.
No altering of facility is allowed. Do not tape, nail, drill, or do anything that would damage structure. NO ELECTRICAL WIRING IS TO BE DONE WITHOUT EXPRESS PERMISSION and then must be installed by a licensed electrician.

Any items deemed by BETS to be of a demoralizing tendency, shall be removed.

BETS shall use reasonable safeguards against fire, theft, and accidents, but does not assume any liability for damages to goods or property of VENDOR from fire, theft, water or storm, or any liability for accidents to persons or property caused under, or by virtue of the operations under this contract.

VENDOR agrees to indemnify and hold harmless BETS, Badlands Circuit Finals Rodeo, their respective agents and employees, from and against all claims, damages, losses, expenses, including reasonable attorney's fees, in case of action, arising out of the VENDOR'S space bargained for herein, filed for bodily injury, illness, or death, or property damage, including loss of use, caused in whole or in part by the undersigned VENDOR'S negligent act or omission, or by any agent of the undersigned VENDOR, or by anyone whose act or mission the VENDOR may be liable.
